### Medical Treatments

I hereby give my permission to Tailwagger's Country Inn, Inc. to act as my agent in case of an emergency, or, in the case of any health issue regarding my pet(s) stay at the Country Inn.

In an emergency I permit the Tailwagger's Country Inn staff to assess the situation and if the need arises, transport my pet(s) to my pets personal veterinarian, the nearest veterinarian clinic, or emergency care facility for medical care.

I agree to reimburse Tailwagger's Country Inn for any and all charges incurred for any medical care, or medications required.

### Vaccinations

I understand that Tailwaggers Country Inn's policy does ensure that all pets visiting are up to date with all animal immunizations.

I hereby declare that my pet has been fully vaccinated by my pet's own veterinarian, or I will fully reimburse Tailwagger's Country Inn for the amount charged by a veterinarian for any vaccination which has expired, or has not been administered (Rabies, DHLPP&C, Bordetella).

I understand that like humans, dogs are susceptible to various strains of viruses and other illnesses. I understand that because there are many strains of viruses,

vaccinations are not 100% effective. Understand that much depends on the dogs, age, stress, immune system and nutritional levels.

I feel confident in the Tailwagger's Country Inn to provide a safe, clean environment in caring for all their guests. I understand that should an accident, allergic reactions, illness, or loss of my dog(s) occur, that I shall not seek retribution.

Tailwagger's Country Inn does take precautions when boarding female guests "in heat" to keep them away from any and all un-neutered male guests; however, they will not be held responsible for any pregnancies, or problems which may arise as a result of the dog not being spayed.

### **Miscellaneous Items**

I understand that Tailwagger's Country encourages guests to play and socialize in designated play areas, which may result in the dog getting dirty or muddy.

I understand Tailwagger's Country Inn will make an attempt to keep my dog as clean as possible and bathing my dog should the need arise.

I understand Tailwagger's Country Inn is not responsible for any lost personal toys or items and does recommend a nametag on all items.

I understand Tailwagger's Country Inn rate schedule and agree to pay billed charges upon completion of services.

I understand Tailwagger's Country Inn has the right to discontinue service to unmanageable or aggressive guests for future boarding.

I understand Tailwagger's Country Inn will not release my dog to any other person other than those whose signature(s) appear below, unless I designate so in writing.

I understand Tailwagger's Country Inn is not responsible for any dog left unclaimed or with a balance due after a 60-day period.

I understand that it is my responsibility to contact Tailwagger's Country Inn if my plans change or the need arises to leave my dog longer than anticipated.
